### Report regarding the Paris meeting of Financial Literacy Researchers of the EIB Institute Grant October 2013

On October 30, 2013, members of the financial literacy group awarded an EIB grant met in Paris at the OECD Headquarters. During this all day conference, participants presented recent work on topics such as mortgages, gender differences, financial education programs, and country comparisons.
